## MINUTES of the Extraordinary Meeting of Coughton Parish Council, held at Knockmore, Sambourne Lane, Coughton, B49 5HS on Tuesday 6<sup>th</sup> June at 10.45 am.

Present: Councillors John Gittins; Len Carter; Maureen McTavish and Roy Piddington. In attendance: 2 members of the public

## 1) To elect a Chairman for the meeting

Councillor Maureen McTavish was duly elected Chairman for the meeting.

## 2) Public participation (10 minutes)

Members of the public expressed their concerns regarding a planning application for an extension to the existing car park at the Throckmorton Arms. A third, unable to attend the meeting, had asked that his views also be presented to the Council.

Concerns raised were the impact of the plan on the Green Belt and the security risk to an adjacent property, since the planned site will not be visible from the road. Residents consider that the description of 'overspill' car park' is inaccurate on account of its size and is therefore misleading, since the plan will almost double the existing facility. As well as the increased crime risk, it was further felt that a doubling of the facility would lead to increased noise pollution and anti-social behaviour. Another worry is that increased delivery traffic on an adjacent shared access will result in hazard and nuisance.

One member of the public produced Land Registry documents detailing a restrictive covenant, limiting development of the site (references WK411957 and WK325100)
